



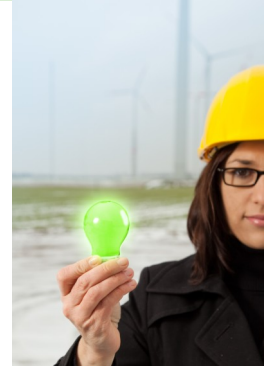
2011 Concrete Industry Day at the Massachusetts Institute of Technology Concrete Sustainability Hub
